Mayor Rose

Mayor Rose spoke about the administrative time and financial resources that have been required to complete the Code of Conducts, noting the costs may exceed \$100,000. He stated its freedom of expression, its freedom of speech but the code of conduct has made it easy to complain and it's a financial and administrative strain on the town.

He recommended to contact the Minister for Government Services to suggest they accommodate an office in Stephenville to address applications and permits.

He stated he will be attending MNL Conference in St. Johns in October.

Councillor Tiller

He provided a synopsis of the MNL Regional Meeting he attended on September 8th and 9th, stating housing and waste management were main topics discussed. He noted Stephenville was given honorable mention for its wastewater treatment facility, tiny home development, and having a renters accommodation listing. It was noted that a renters list was formed by the town; however, it has not been updated in many years.

Mayor Rose in response stated the private sector needs to be supported by all levels of government to ensure there is affordable housing.
