Designated Areas for Overnight Camping

Designated areas include: Kincourt – until August 15, 2023, approved campgrounds, or residential property as a temporary activity.

Mayor Rose stated the decision to limit camping to designated areas was due to increased campers on the beach, the aesthetics and the number of complaints. Council has provided a solution that will still allow camping with access to the beach and the town will provide enhance services at Kincourt. Councillor Tiller agreed and praised the council and staff for finding a solution. The Chief Administrative Officer added campers are also parked in downtown area, and this will provide a measure to regulate.
